ORDER:

In the G.O. 4th read above orders were issued regarding revision of pensions in respect of those Judicial Officers who retired prior to 1.7.1996 as recommended by the First National Judicial Pay Commission.

- 2. The First National Judicial Pay Commission recommended a separate pension structure to all those Judicial Officers who retired prior to 1.1.1996 (called past pensioners) and the same has been accepted by the Supreme Court with certain modifications. Therefore the G.O.Ms.No.79, Law (LA&J SC.F) Department, dated 17.07.2004 shall be applicable only to those Judicial Officers who retired prior to 1.7.1996.
- 3. The A.P. Retired Judicial Officers Association filed a petition in I.A.No.157 of 2004 in W.P.No.1022 of 89 in the Hon'ble Supreme Court praying to set aside the orders at para 8 of G.O.Ms.No.79, Law (LA&J SC.F) Department, dated 17.07.2004 to the extent "who have put in full qualifying service at the time of retirement. In respect of Judicial Officers who have put in less than the full qualifying service there shall be proportionate reduction."
- In the reference 6th read above, the Hon'ble Supreme Court of India in its Judgment dated 21.11.2006 allowed the !A.No.157 of 2004 in W.P.(C) No.1022 of 1989 setting aside the orders at para 8 of G.O.Ms.No.79, Law (LA&J SC.F) Department, dated 17.07.2004 to the extent "who have put in full qualifying service at the time of retirement. In respect of Judicial Officers who have put in less than the full qualifying service there shall be proportionate reduction."
- 5. In view of the Judgment of the Hon'ble Supreme Court of India dated 21.11.2006 in I.A.No.157/2004 in W.P. (C)No.1022/89 it has become now necessary to amend appropriately the G.O.Ms.No.79, Law (LA&J SC.F) Department, dated 17.07.2004.

Accordingly the following words from para No.8 of G.O.MS.NO.79 Law (LA&J SC F) Dept., DT:17.7.2004 are hereby deleted.

"who have put in full qualifying service at the time of retirement. In respect of Judicial Officers who have put in less than the full qualifying service there shall be proportionate reduction."

- In respect of those judicial pensioners consequent to this amendment where there is a change in the amount of pension already revised in terms of G.O.Ms.No.79 Law (LA&J SC F) dated 17.7.2004, those pensions shall be revised and refixed as per this amendment/issued at para (6) above. This is a one time dispensation for those Judicial Officers who retired before 01.07.1996.
- The arrears of pensions which may become payable consequent to the fixation or re-fixation of pensions as per this G.O. shall be paid to the pensioners and in case where the pensioner died, to the family pension holder or his legal heir as the
