DRDER:

In obedience to the above directions of the Hon'ble Supreme Court of India, the State Government ordered that the Revised Pension of the Judicial Officers who have retired or died while in service on and after 01-07-1996 shall be 50% of the minimum of the time scale in the revised pay scales of the post held by the Judicial Officers at the time of retirement or death vide reference 8th read above.

- The Accountant General (A&E), Andhra Pradesh, Hyderabad has requested clarification whether DCRG can be calculated and CVP can be authorized with teference to the pension worked out as per Para 9 and 10 of the G.O. Ms. No. 113, Law (LA&J-SC.F) Department dated I-11-2004 vide reference 9th read above. He has also requested to consider issuing orders to sanction DCRG and commutation based on the minimum of the Revised Pay scale of the post held by the Judicial Officers at the time of retirement. It is further requested that if DCRG and CVP are also Euthorized necessary instructions prescribing the procedure for recovery of the excess gray and allowances, if any, paid consequent on getting clarification with reference to grara 11 of the G.O. Ms. No. 113, Law (LA&J-SC.F) Department dated 1-11-2004.
- The Government after careful consideration of the matter have decided to release DCRG to the retired Judicial Officers as per the eligibility without any reduction as per Para 9 &10 of G.O. Ms. No. 113, Law (LA&J-SC.F) Department dated 1-11-2004, subject to the decision of the Hon'ble Supreme Court of India in IA.No.152/2005 and if due to this, any excess payments are paid, then the same will be recovered during commutation of the Pension payable to these Judicial Officers and also from the Dearness Relief, if necessary
