In the letter 3<sup>rd</sup> read above, the Registrar General, High Court for the State of Telangana at Hyderabad, has stated that during establishment of Courts in the new Judicial districts some districts remains with only one District Court without additional Court which is overburdened and hence, the High Court proposed to shift certain Courts so regularized from one place to another place and also certain regular Courts as mentioned therein for functioning in the proposed places either as Principal Courts or Additional Courts, and requested for approval of the same and issue necessary orders in the matter accordingly.

2. Government, after careful examination of the proposal of the Registrar General, High Court for the State of Telangana at Hyderabad, hereby approve and order for shifting and renaming of the following Courts mentioned in Column No.2 of the table below to the new stations mentioned in Column No.3 of the table below:-
